ELECTRONIC FUNDS TRANSFER AUTHORIZATION

Note: *You will be enrolled in this service only if you sign and date below.* Sign below to have your annual membership fee paid in monthly installments which will be automatically deducted from your financial institution, or charged to your credit card, according to your processing information. Pay the “Initial Monthly Installment” by check and we will use the account information on your check to make your future payments. Payments will be deducted from your financial institution within three business days of the 8th of each month or the withdrawal date specified below

Pay the “Initial Monthly Installment” by credit card and we will use the account information from your credit card to make future payments. Payments will be charged to your credit card on the 8th of each month. We can process the following credit cards: Visa, Master Card, Discover or American Express.

Annual Membership Investment - \$400

Auto-Pay Option - \$50
